SUGGESTED COURSE SEQUENCE-- Last Modified 8/16/2021
For Students Entering Rowan CORE Program Fall 2021 and after

PLEASE NOTE: Considerable flexibility exists for moving courses between spring and fall semesters, except when a course is only offered in spring or fall (noted in some required major or specialization courses). When altering course sequences, give careful consideration to prerequisites. Also, be cognizant of the following when making your schedule:

1. **Supervised Internship in Accounting & Taxation of Business Entities are highly recommended as Accounting Electives during junior or senior year. Taxation is especially important for those planning to sit for the CPA exam.**
2. **Senior Privilege—If you have 90 credits and at least a 3.0 GPA, you may take one graduate course each semester during senior year for no extra cost. Contact your advisor or the RCB Assistant Dean for Graduate Studies for information.**
3. **CPA exam—You may sit for the CPA exam with an Accounting degree and 120 credits, but you need 150 credits before you are issued your CPA license. In addition, many large CPA firms will not hire anyone unless they have earned 150 credits before they start working. Thus, many of you may consider accumulating 150 credits at the undergraduate level before earning your degree. A good way to do this is adding a dual major, CUGS or minoring in another discipline.**
4. **GMATS—If you plan to go to graduate school after completing your undergraduate degree, please plan to take and study for the GMATs during your senior year.**
5. **120 credits must be completed in order to earn your degree. Please be sure to pay attention to your credit total in addition to completing the required courses.**
