## PENNSYLVANIA CLE CREDIT

In order to allow New Jersey attorneys who are also licensed in Pennsylvania to more conveniently satisfy their Pennsylvania CLE requirements, NJICLE became an approved CLE sponsor with the Pennsylvania CLE Board.
